- 2. **Books**: they as a source of reference to both the mathematics teachers and students. They supply currents information which will help both teacher s and learners to achieve the objectives of the lesson example Textbook, Laboratory Manuals, teachers guide (lesson note) students' notebooks etc. These improvisations are used in all fields or area of mathematics.
- 3. **Models**: These are concrete device used by teachers and students. to demonstrate mathematical concepts. They are broadly classified into two.

- a. **Opaque Materials**: concrete models for which the external part is to be considered and as such are made from opaque materials. e.g. cone, cylinder etc.
- b. **Transparent Materials**: these are concrete models in which the internal structure are required and are constructed from transparent materials e.g. water proof etc. examples of such models are cuboids, sphere, triangular prism etc. These improvisations are also applicable are also applicable to. - 4. **Mathematical Games**: these are game puzzles in mathematics meant to stimulate students interest and encourage reflexive thinking. It is a new development in mathematics known as "joyful learning". They are applied to all areas of mathematics.
- 5. **Mathematical Laboratory**: These are special room or space reserved in a school for the purpose of conducting practical tasks in mathematics. It supports the concepts of learning by doing and promotes students' perception of theories learnt in the classroom.
- 6. Construction materials e.g ruler, protractor, Compass: they are used for construction purposes.

Criteria for Improvising Improvisational Materials The mathematics teacher is expected to put into consideration the following factors in selecting and using improvisation materials to enhance learning.

- 1. Age and ability of the learners: The teacher must put into or providing improvisational materials. This is because. When an improvisational materials provided are above the learners' cognitive ability, he will not understand the concept. Rather he will be confused.
- 2. Topics within the syllabus that, the students or pupils are not Conversant with.
- 3. The learners psychology: participation and attention. Improvisational materials consider the learners characteristics like readiness, interest and ability to stimulate their participation and attention.
- 4. They should be free from any kind of danger: every resource, materials should be harmless. They should never endanger the health of the learners and teachers.



- 5. A good improvisation should not be faulty: Improvisational materials to be used in the class must be in good condition and mechanically alright.
- 6. Relative to lesson objectives: Every teaching improvisation to be used should facilitate the learners learning. It must be centre on achieving a good lesson objective.
- 7. Currency information: Every teaching improvisation to be used must be current enough to supply information to students accurately.
- 8. They should be relevant and easy to get: Resource materials to be used in the class must be very cheap and very easy to get. It must equally be very much related to the topic of b) discussion in class.
- 9. Consider bringing the known to teach them the unknown, that's, what children see and do stays longer than mere learning.

Conclusion

The government should set-upon agency or body that will be Supervising the primary and secondary schools in the aspect of the availability and usage of mathematics improvisational materials. In general, teachers should be sponsored to conference and workshops so as to improve on their method of communicating mathematics concept in the classroom.
